Included in the report are statistics related to the department's calls for service and total offenses charged. You will also find breakdowns of what types of calls officers responded to and what types of charges were filed against criminals and/or violators.

I may also give my opinion on why the department is seeing increases in particular areas of interest and decreases in others. This report is not an all- inclusive document, but rather a synopsis of events occurring in 2005 along with explanations/opinions on why we are seeing these trends. 1. Traffic Accidents
In 2001 we had 119 *Accident Calls* reported. In the years since 2001 we have seen an average of 98 per year with 2005 recording 96. Aggressive enforcement of speed and inattentive driving laws can be attributed to the decrease in accidents since 2001. The department has taken an active role in the Minnesota Safe and Sober Program for the past 5 years.
2. Burglaries
We experienced a sharp increase in *Burglary* incidents in 2004; however the incidents leveled back off in 2005 with 14 reports.
3. Disturbance Calls
Our calls for *Disturbances* have decreased dramatically, down from 242 complaints in 2004 to 176 in 2005. The average calls for disturbances over the prior four years were 258.
4. Narcotics
We saw a major increase in *Drug Related Calls* in 2005. In 2004, we answered 9 Drug Related Calls and it increased to 28 in 2005. We answered these calls with aggressive investigation and enforcement. I assigned an officer to work directly with the CEE VI Drug Task Force to combat these problems. Our efforts resulted in 21 narcotics arrests in 2005.
5. Domestic
We are continuing to answer numerous *Domestic Assault Calls* and *Domestic Disturbances* calls every month. We investigated 15 Domestic Assaults and 11 Domestic Disturbances in 2005). The department continues to work closely with Swift County Human Services and Victim's Advocates in these cases. 16 suspects were successfully charged on the 15 Domestic Assault cases in 2005.
6. Traffic Offenses
Our calls for *Traffic Offenses* have leveled off at 150 calls in 2005. Over the four years prior, the average was 145 calls. As noted above, we have focused more on traffic safety in recent years.
7. DUI
Over the past two years, we have seen a sizable increase in *DUI* arrests from 10 arrests in 2002 to 22 arrests in 2005. We also charged 4 individuals with *underage drinking and driving* in 2005. Note: There were 4 motor vehicles forfeited in DUI cases in the year 2005.
8. Suicide / Suicide Attempts
The department responded to 6 *Suicide / Suicide Attempt* calls in the city limits in 2005. In addition to these incidents, officers assisted the Swift County Sheriff's Office with numerous suicides and attempts. The exposure of our officers to these incidents is always a concern to leadership staff.

9. Total Charges Our total of number of charges has increased from 413 charges in 2001 to 569 in 2005. We experienced a spike in charges in 2003 with 696 total charges when we had 7 Full-time officers.
10. Total Calls for Service The police department answered 2900 calls for service in 2005, which was 2% lower than the 2983 calls in 2004.

Community Involvement

The Police Department continues to be very involved with the community. We are currently involved in a number of Community Policing Projects to include: Senior Citizen Assistance Program, Child Seat Program, School Resource Officer Program, DARE Program, Bike Rodeo, Driver’s Education and the Crosswalk Safety Campaign and Safe & Sober. We serve on the following organizations: CEE VI Drug Task Force, the Swift County Child Protection Team, the Swift County Adult Protection Team, Minnesota Chief’s of Police Executive Board and the City of Benson Safety Committee.

Training

We take training very seriously and make it a priority to have our officers trained to the highest level possible while staying within budget constraints. Officers attended the following course in 2005:
