### **§ 71.01 PARKING NEAR FIRE HALLS.**

No person shall park any automobile or other motor vehicle in front of any fire hall in the city for a distance of 50 feet from the front center of the fire hall.

### **§ 71.02 PARKING NEAR INTERSECTIONS.**

No person shall park any automobile or other motor vehicle within 20 feet of the corner of any street within the city.

### **§ 71.03 PARKING NEAR FIRE HYDRANTS.**

No person shall leave or permit or cause to stand or remain any carriage, car, wagon, sleigh, motor

vehicle, or vehicle of any kind under his or her control in the roadway of any public street or highway in the city within 15 feet of any hydrant in the public street or

highway.

**§ 71.04 ANGLE PARKING.**

Every vehicle parked or stopped upon any of the streets and avenues designated for angle parking shall be parked at an angle of 45° to the curb or boulevard at the right-hand side of such street or avenue and with the right-hand front wheel of the vehicle touching or within six inches of the curb or boulevard. On such streets or avenues so designated which are paved, vehicles shall be parked or stopped within the parking lines painted on the pavement. The parking regulations specified in this section shall apply as indicated by road and street signs.

**§ 71.05 PARALLEL PARKING.**

Every vehicle parked or stopped upon any street or avenue with a curb, except streets and avenues described in § 71.04, shall be parked parallel to and with the right-hand wheel or wheels of such vehicle within 12 inches of the curb. On other streets and avenues, except streets and avenues described in § 71.04, a vehicle shall be parked to the right of the main traveled portion thereof and parallel thereto and in such manner that it shall not interfere with the free flow of traffic.

**§ 71.06 DOUBLE PARKING.**

No person shall park or stop any vehicle alongside or on the roadway side of any parked vehicle on any streets or avenues within the city.

**§ 71.07 TIME LIMITS.**

(A) No vehicle shall be parked or stopped on any of the streets or avenues so designated by signs in any one place for a longer consecutive period than 90 minutes between the hours of 8:00 a.m. and 8:00 p.m. on any day except Sunday. This parking time limit shall apply as indicated by road and street signs.

(B) No vehicle shall be parked or stopped on any other streets or avenues in the city in any one place for a longer consecutive period than six hours between the hours of 8:00 a.m. and 8:00 p.m.

## **§ 71.08 TRUCK-TRACTORS AND SEMI-TRAILERS.**

(A) No combination truck-tractor/semi-trailer vehicle, or separate semi-trailer in excess of 15,000 pounds licensed gross weight shall be parked or permitted to remain upon the streets or avenues within a One- and Two-Family Residential Zone (R-1); a Multi-Family Residential Zone (R-2); or a Limited Family Residential Zone (R-3) as designated on the Zoning Map of the city, provided that the stopping of said trucks for the purpose of loading or unloading for such time as is necessary therefor will not be considered a violation of this section. ('75 Code, § 7.139)

(B) No truck-tractors shall be parked in any residential area as set forth in subsection (B) with the motor running for a consecutive period of more than one hour. ('75 Code, § 7.145)

(C) No semi-trailer which is not attached to a truck-tractor designed to pull it shall be parked on any public street or in any R-1, R-2, or R-3 residential district. ('75 Code, § 7.146)

## **§ 71.09 PROHIBITED PARKING.**

No person shall park a vehicle or permit it to stand, whether attended or unattended, upon any street or avenue within the city in any of the following places:

(A) On a sidewalk or boulevard;

(B) In front of a public or private driveway;

(C) Within an intersection;

(D) Within ten feet of any fire hydrant;

(E) On a crosswalk;

(F) Within 20 feet of any intersection unless otherwise provided by city police officials;

(G) Within 20 feet of the nearest rail or a railroad crossing;

(H) Alongside or opposite any street excavation or obstruction when such stopping, standing, or parking would obstruct traffic;

(I) At any place the City Council may designate as a no parking area and so indicate with an official sign or yellow marking.

#### **§ 71.10 TRAILER PARKING.**

No person shall, for camping purposes, leave or park a house trailer on any street or avenue or the right-of-way thereof.

#### **§ 71.11 VEHICLES FOR SALE.**

No vehicle shall be parked on any street or avenue for the purpose of displaying it for sale.

#### **§ 71.12 CONSTRUCTION OF DRIVEWAYS; DESIGNATION OF NO-PARKING AREAS.**

No person shall construct a private driveway or entryway through the right-of-way, sidewalk, or boulevard of any street or avenue or designate a no parking area along any street or avenue without written permission signed by a majority of the City Council Members.

### **§ 71.13 SNOW EMERGENCIES.**

During any time that snow plowing or snow removal operations are reasonably required on streets, alleys, or public parking lots, and particularly for a period of 72 hours commencing immediately after the cessation of any two inches or more of continuous snowfall and until the snow plowing or removal has been completed in the area involved, the parking of vehicles on the streets and avenues shall be as follows:

(A) Parking will be prohibited on streets between the hours of 8:00 a.m. and 7:00 p.m. and on avenues between the hours of 10:00 p.m. and 8:00 a.m. Parking will be permitted on public parking lots during the hours at which time it is prohibited on streets and avenues. Following the completion of snow removal operations on streets and avenues, parking shall resume on those cleared areas to facilitate snow removal on public parking lots.

### **§ 71.99 PENALTY.**

(A) Any person, firm, or corporation who violates and provision of this chapter for which another penalty is not specifically provided shall, upon conviction, be penalized as provided in § 10.99.

(B) Every person convicted of a violation of § 71.15 shall be punished by a fine of not more than \$25. ('75 Code, § 7.250) (Ord. 1005.77, passed - -77)
